Alliance Says President's FY 16 Request for FDA is "Welcome"

President Requests Appropriation of \$2.746 Billion--A \$147 Million (6%) Increase

Silver Spring, MD, February 2, 2015 –The Alliance for a Stronger FDA said it "welcomed" President Obama's FY 16 budget request for FDA. While it falls short of the money needed to meet FDA's new and expanding responsibilities, the President's request would double the increase in base funding over the prior four years, the Alliance noted. As such, "it is welcomed by the FDA stakeholder community," said Jeff Allen, PhD, President of the Alliance and Executive Director of Friends of Cancer Research.

The Alliance, whose almost 200 members represent a cross-section of FDA stakeholders, has emphasized that "substantial increases are needed to support FDA's critical mission," Allen said. At \$2.746 billion, the agency's appropriation would increase by \$147 million, nearly a 6% increase.

"We urge the House and Senate appropriations committees to recognize the same FDA needs that the President has," Allen said. "The additional funding for food safety, precision medicine, drug compounding oversight, and antibiotics development will make a huge difference at the agency."

"At the same time, however, we can also point to other FDA programs that need and warrant additional funding," Allen added. "The Alliance will continue to advocate for this additional funding."

Under the President's budget request, food programs (CFSAN + CVM) are proposed to grow by more than \$100 million, over 4%. Medical product programs would grow by about \$20 million slightly less than 1%. The proposal also includes \$29 million for rental payments, about 1%, which are expenses that would otherwise be paid out of the Center budgets. (See chart on page 2).

"It is a national priority for FDA to have the resources it needs to meet the challenges of medical advances, a changing global economy, and food safety," said Cynthia Bens, Vice President of the Alliance and Vice President for Public Policy of the Alliance for Aging Research. "No other Federal, state or private agency provides a fallback if FDA can't fulfill its mission."

"The monies for food safety are particularly timely given the FDA's multi-year responsibility for implementing the Food Safety Modernization Act (FSMA)," said Chris Waldrop, Alliance Board member and Director of the Food Safety Institute of the Consumer Federation of America. "FSMA represents a fundamental change in philosophy and programming and the agency needs sufficient resources to effectively implement the law."

The Alliance's nearly 200 members are comprised of consumer, patient, professional and research groups, companies, trade associations, and individuals who support increased appropriated funding for FDA. The Alliance is the only multi-stakeholder group that advocates for increasing resources at FDA to match the agency's responsibilities.
